She said there is an agreement with him that he is prohibite prohibits connecting his driveway to the Association's right of way driveway on Association property. He has a lease with the Association to use the Association driveway to access his property, and he is not allowed to expand on the lease. P. Heslin said they had drawn up an agreement with Mr. Franzoni and he agreed to it in writing. She offered to supply the BOG with background information.

P. Formica received an email from Mr. Franconi Franzoni which stated he is going to pave the apron on Association property. It was the consensus of the BOG that the apron is not to be paved. P. Formica will set up a meeting with Mr. Franconi Franzoni. Vote: APPROVED unanimously.

There are two vacancies on the Board and there are three people who are interested in the positions.

Carry Kerry Orshal introduced herself as being interested in a seat on the BOG. She has been involved for many years, especially on the recreation committee. She would like to use her position on the BOG to advocate for youth activities in the association.

Ernie Annibale is also interested in serving on the board.

Jerry Tramontozzi as a candidate to work on issues dividing the community. He would like to give back to the association.

Phyliss Berger would like to know if there was any follow up on how to invest the association's CD savings. P. Formica said they are still pursuing options.

8. Committee Reports

M. Heenehan reported that she would be sending out an opinion survey concerning the clubhouse, grounds, and improvements. She said she still needs an estimate for landscaping and winterizing the club house plumbing.

She said texting is now available for emergency and important information to the association. M. Heenehan said 63 people have signed up to receive texts.

When researching options for internet at the clubhouse most carriers consider the clubhouse to be a business account which is more expensive than a residential service.

Ernie Annibale gave an update on the Zoning Commission. He spoke highly of the new Zoning Enforcement Officer, Jim Ventres who would be taking over most of the work previously done by the Commission. J. Ventres has reviewed the regulations and has suggested revisions to bring them in compliance with the state regulations.

P. Formica was concerned that if the ZEO is doing most of the approvals then there would be no stamp of approval from the Commission.

P. Formica thanked the Bergers for volunteering for the Committees.

10. Discuss 216 Giants Neck Rd Driveway Lease/Outstanding Issues

Piscatelli discussed the difficulty Mr. Franzoni will have accessing his garage without the use of the Associations permission to use the driveway. He suggested extending the lease but for a shorter time and to take into consideration the valuation to the Association for providing a lease.
